ILS-195 review before submission

- Two weeks prior to April 1, 2021 deadline by Data Officer
- Data accuracy, consistency, quality
- Best practice (also for other data reports to ILS)
- Understanding data flow and data sources



ILS-195 source documents

- Source document = the document or source from which the requested information is derived for each individual case.
- Examples:
 - CAFA cover sheet / CAFA intake form
 - Pre-printed case file folder
 - Case closing form
 - Voucher


