




Overview of Demographic Information



Criminal Defense Representation Experience




Overview of Demographic Information



Respondents' Criminal Defense Representation by Top Charge


Counties in Which the Survey Respondents Provided Criminal Representation












Q9: Has implementation of CPL Article 245 impacted your ability to negotiate with the prosecution for agreed upon dispositions in your cases?




