Who should attend this training?

This training is designed for all providers of mandated representation, their staff, and any other interested party that is involved in data collection/reporting to ILS.

How do I register for a training session?

What topics will be discussed during this training?

This training will focus primarily on how to complete Part 2 of the ILS-195. Part 2 is due in April 2021, meaning providers should start collecting the data on January 1, 2020. Please note that in December 2018, ILS offered online trainings that covered, among other things, how to complete Part 1 of the ILS-195 (due for submission in April 2020). Each training session allows a **maximum of 25 participants** and is expected to last about **2 hours**. There will be plenty of opportunities to ask questions.
